### Important Cases

***R (Yekini) v Southwark LBC [2014] EWHC 2096 (Admin).***

Represented the Authority: significant case concerning housing and its financing for Zambrano carers. Appeal to Court of Appeal pending.

***Huzrat v Hounslow LBC [2014] HLR 70***

Successfully represented Authority in resisting application of “best interests of child” and ZH Tanzania to relation to Housing Act Part VII decisions. Application to appeal to Supreme Court pending.

***Pryce v Southwark LBC [2013] 1WLR 996***

Represented Authority in appeal concerning eligibility of Zambrano carer and associated questions.

***Dharmaraj v Hounslow LBC [2011] HLR 18 (Court of Appeal)***

Successfully represented Authority in resisting challenge based on wording of appeal notification in a decision under Sec 202 of the Housing Act 1996.

***De-Winter Heald v Brent LBC [2010] 1 WLR 990***

Appeared for the successful Local Authority in three conjoined appeal in which the Court of Appeal confirmed the lawfulness of contracting out reviews under Sec 202 of the Housing Act 1996, and dismissed challenges alleging appearance of bias on the part of the decision-maker.

***Novitskaya v Brent LBC & Sec of State [2010] HLR 21***

Represented a Local Authority in the Court of Appeal in appeal about the time limits for Housing Benefit claims etc.

***Wilson v Ashford BC [2011] Env LR D1 (Admin Court)***

Represented landlord in appeal by Case Stated in relation the costs awarded to Local Authority in respect of abandoned appeal to the Crown Court. Inconsistency between Sec 109 MCA and Crown Court Rules.

***Ugiagbe v Southwark LBC [2009] HLR 35 (Court of Appeal)***

Represented Authority in appeal concerning intentional homelessness. Applicant unaware of her right to remain in property until possession order but failed to follow advice, which would have prevented her homelessness. Court of Appeal considers whether such conduct was “in good faith.”

Solicitors Disciplinary proceedings

Represented solicitor in appeal to Court of Appeal by the Law Society challenging the result of a successful appeal to the Administrative Court. Principles touching the striking-off of solicitors reviewed.

Public law: education

Represented college of University in the High Court and Court of Appeal in resisting claim by former student alleging mis-application of examination rules and like complainants

Represented Authority in the Court of Appeal, in appeal by solicitors against wasted costs order made in the County Court, arising from the last minute introduction of a fresh point

Housing; allocations policy

***Osei v Southwark [2008] HLR 15 (Court of Appeal)***

Housing – homelessness

Intentional homelessness; giving up of accommodation abroad to move family to UK. Authority's decision upheld.

Establishes the correct approach to s.193(7F) Housing Act 1996

European Union – Compensation For Victims Of Untraced Drivers

Challenge to the compliance of the UK's Motor Insurers Bureau scheme with relevant EEA obligations.

***Paragon Finance v Pender [2005] 1 WLR 3412 (Court of Appeal)***

Mortgage interest rate challenges; assignee's title to sue

Appeared for borrowers in appeal against possession order on the basis that the mortgage lender, by virtue of securitisation arrangements in respect of the mortgage had no title to sue or was in breach of an implied term not to vary interest rates capriciously, or on grounds that the mortgage was an extortionate credit bargain.

***Southwark LBC v Mills [2001] AC 1, House of Lords***

Landlord And Tenant – Housing – Local Government – Nuisance – Real Property

This case settled important points in housing and landlord and tenant law, whether the covenant of quiet enjoyment and the tort of nuisance may be enlisted to compel landlords to install soundproofing. The case has particular significance for social landlords and their tenants

***Luck v Tower Hamlets LBC [2003] EWCA Civ 52 (Court of Appeal)***

Contracts – Human Rights – Local Government – Torts

Appeared for excluded contractor in claim against Authority for breach of obligations under the Public Services Contracts Regulations 1993 SI 1993/3328 and for misfeasance in public office.

***Paragon Finance v Nash [2002] 1 WLR 685, Court of Appeal***

Challenge to mortgage interest rates

Appeared for borrowers in challenges to secondary lender's interest rates. This case establishes that commercial mortgage lenders were under a duty not to vary interest rates dishonestly, capriciously or Wednesbury unreasonably.
