Social Housing

Jenny is a former member of the housing team at Hodge Jones & Allen Solicitors, where she was identified as a leading individual in the field of social housing. She is ranked as a leading junior and is regularly instructed by local authorities, housing associations and tenants across all aspects of housing law. Her practice areas include:

- Possession – succession, tenancy fraud and anti-social behaviour
- Public law – homelessness appeals, allocation and Equality Act/PSED/proportionality defences
- Injunctions and committal – ASB, access and breach of tenancy
- Court of Protection and mental health
- Housing conditions, disrepair and environmental health

Recent Instructions:

- *Camden v Etienne* (2024 unreported) – Jenny successfully applied to strike out a disability defence on the basis that illiteracy did not arise from a mental or physical impairment.
- *Rowe v Haringey* [2022] EWCA Civ 1370, [2022] 10 WLUK 270 – Jenny (led by Nicholas Grundy KC) was successful in the Court of Appeal in this homelessness appeal on the issue of overcrowding and whether it is reasonable for a homeless applicant to remain in accommodation in an HMO.
- *Molloy v BPHA* [2021] EWCA Civ 1035 – Jenny successfully appeared as sole counsel in this appeal against the use of CCTV and committal for racist abuse.
- *Peabody v Denti* (2021) – Jenny secured final injunctive relief to exclude a tenant who had set a fire in their housing block, arguing that even if there was a diminished risk of repeated behaviour, other residents were at risk of harm due to trauma.
- *Luton v Smith* (2020) – Jenny resisted an unlawful discrimination/ PSED defence and secured a final injunction in circumstances where the medical report with details of the alleged medical conditions had been served late (following *L&Q HT v Patrick* [2019] EWHC 1263 (QB)).
- *Grant v L&Q and Usuanlele* (2020) – Jenny struck out the EPA prosecution on the basis that the notice fell foul of the requirements in s82(6).

Private Client

Jenny is the leader of the Private Client team at Five Paper. She acts on applications under the Trusts of Land and Appointment of Trustees Act 1996 including challenges to beneficial interest in property, as well as issues of contentious inheritance, wills and probate.

Recent work includes:

- Advising on the presumption of advancement and proprietary estoppel in the context of a large family estate;
- Opposing a contested application under s14 TOLATA 96 for an order for sale;
- Advising on claims under the Inheritance (Provision for Family and Dependents) Act 1975
- Representing a former cohabitee in a TOLATA dispute to establish a beneficial interest in the home

Public Law

Jenny is regularly instructed in homelessness appeals and housing judicial reviews. She has long-standing relationships with many local authorities and appears as sole counsel in homelessness matters in the County Court, the Administrative Court and the Court of Appeal. She also deals with urgent applications for interim relief.

Recent work includes:

- Advising a local authority in the interpretation of their constitution regarding the contracting out of their homelessness functions.
- Successfully opposing an urgent application for interim relief on the basis that it lacked merit.
- Advising on the merits of and representing the local authority in a homelessness review decision focused on suitability.
