### Recent experience

#### *Leaseholder disputes*

- Acted for large social landlord leaseholder in services charges dispute with freeholder of mixed tenure block. Case raised novel points about interpretation of consent order following county court proceedings and third party claims in the Property Tribunal.
- Advising local authority in respect of claim by leaseholders in relation to leaks from common parts. Issues raised about competence of SJE in case of major works. Complex issues relating to extent of landlord's obligations.
- Represented social landlord in complex three-party mediation relating to large block of mixed residential and commercial use. Issues relating to liability for pipes, inherent defects and foresee ability of loss of business profit.

***XY v HARINGEY LONDON BOROUGH COUNCIL (2019)***

***[2019] EWHC 2276 (Admin) reported on Lawtel: [2019] 8 WLUK 278***

Acted for the local authority in a judicial review challenge to Homelessness Reduction Act assessments. Initial assessments were unlawful but the court held there was no duty to carry out further inquiry, and the most recent assessment identified the claimant's key needs and was held to be adequate and lawful. There was no existing authority on the meaning of "housing need".

Court of Appeal successfully responding to appeal on issue of intentional homelessness and discharge of duty to the homeless.
